BASES TO AWARD THE COURSE PLACE

1. To formalize this reservation of place must be paid to the Tagaste Student Housing Leon the amount of € 125 as a reservation of place (non-refundable) + deposit of the amount of the monthly payment.
2. The following documentation must be attached to the application:
 - a. Proof of payment of registration (125 euros) and then proof of deposit.
 - b. Two updated passport-size photographs
 - c. Photocopy of D.N.I. or passport
 - d. Photocopy of the social security card
 - e. Communicate if the resident has any treatment, pathology or food intolerance that we should know.
3. Once the lists of admitted students of the university have come out, to formalize the reservation a deposit must be made in the bank for the amount of an advance monthly payment, an amount that will always be refunded, except in the cases established in the Internal Regulations.
4. The renunciation of the place granted, the disciplinary expulsion or the abandonment of the residence before the end of the academic year of 9 months, will mean the loss of the entire deposit.
5. The full monthly payment will be paid during the first 10 days of each month. The non-payment of two monthly payments will mean the definitive cancellation of the residence, as established in the Internal Regulations.
6. At the time of accepting the place, it will be essential to comply with the Internal Regulations signed.
7. All requests will be answered, but the documentation submitted will not be returned.
8. Regarding the use of image for advertising, we will abide by what is specified in the Internal Regulations.
9. **In any bank receipt delivered it is mandatory to indicate in the concept name and surname of the resident and the type of payment that is made (DEPOSIT, REGISTRATION, MONTHLY PAYMENT OR CLEANING)**

 - † Once the lists of admitted students leave, they must enter a month's deposit (it is returned at the end of the contract, if the use of the facilities has been correct) and send the rest of the documentation that has been indicated.

SERVICES, FACILITIES AND ACTIVITIES

SERVICES (Included in the fees paid)

- +T **Dining service.** It includes breakfast, lunch and dinner every day of the week except dinner on Sundays. There is the option to choose two menus at meals and two main courses for dinners. If you are not going to eat at the residence you can take the picnic, always upon request.
- +T **Bed and bath linen.** They have bed and bath linen and we take care of their cleaning and replacement.
- +T **Self-service laundry.** Washer, dryer and iron available to our residents.
- +T **Cleaning service.** Daily cleaning of the common areas and weekly of the rooms.
- +T **Internet service.** All rooms have Wi-Fi internet connection. The library and study rooms also have cable access.
- +T **Reception service and video surveillance 24 hours.** Free and controlled access 24 hours a day with control of night outings. Delivery and collection of mail and parcels and access control.

FACILITIES

- +T We have a total of 85 rooms distributed in: 75 single rooms, 10 superior single rooms. All with private bathroom.

ACTIVITIES

+T ROOMS

- +T The rooms are a place of study and rest, and therefore, in them and in the adjoining corridors, silence should be kept and avoid noise or anything that may disturb colleagues.
- +T Each resident will receive at the time of entry the room in perfect conditions of use, as well as the belongings that contain the room. Throughout your stay in the residence it is your responsibility to take care of and maintain all this material. You must warn of any breakdown or deterioration that occurs, in order to solve it as soon as possible.
- +T Each resident will be given a duly numbered key to their room. It must be held accountable for it. When you are absent for a day, you must leave the key to the reception staff. The changes of room that are requested, during the period of the contract, if possible, will be authorized by the management.
- +T The residence is not responsible for the disappearance or deterioration of any personal, material object of work or value (money, jewelry, etc.).

+T COMMON AREASS

- +T The residence has common spaces and areas, such as: hall, library, study room, TV lounge, games area, terraces, self-service laundry (washing machine, dryer, folding table and ironing board). They are available to residents at certain times.

+T SCHEDULES

- +T The established schedules within the residence, meals and access to study areas must be respected.
- +T The residence will remain open 24 hours a day.
- +T Dining hours:
 - Academic; Saturdays, Sundays and holidays;
 - Breakfast 07:30h. to 09:00h. Breakfast 10:00h to 11:00h.
 - Lunch 13:45h to 15:15h. Lunch 13:45h to 14:45h.
 - Dinner 20:45h to 21:45h hours. Dinner 20:45h to 21:45h. (Sunday no dinner)

+T DINING ROOM

- +T Breakfast - Lunch - Dinner - Desserts will vary daily.
- +T These services are offered throughout the school year, except for the Christmas and Easter holiday periods.
- +T It is not allowed to take Food or crockery out of the dining room.
- +T NOTE: The dining hours indicated above are only alterable when the resident for reasons of class schedules cannot maintain them, in which case the food may be served outside the established hours after consultation with Management.
- +T It will be mandatory to present class schedules to justify the reservation of food outside the established hours.

+T CLEANING SERVICE

- +T The residence staff will clean the common areas every day. Weekly rooms will be cleaned, and the resident will be made easier to change towels and sheets.

+T LAUNDRY

- +T The washing of bed and bath linen will be carried out by the residence, although each resident must take care of making the appropriate changes of sheets and towels.
- +T For the personal clothes of the residents have at their disposal laundry service (washing machine, dryer, iron).

+T RESIDENCY CALENDAR

- +T The residence will be governed by the calendar of classes and vacations marked by the University of Leon, closing therefore in the holiday periods, in which period the resident may leave their belongings in their room. The amount of the monthly payments will not be altered.
